- 3.4 Certified evidence of B-B.B.E.E. contributor status by SANAS, IRBA or SANAS accredited agencies; or sworn affidavit of DTI.

- 4. MBD 4, 8 and 9 forms obtainable from the municipal website must be completed and signed.
- 4.1 Bidders must be registered on the Central Supplier Data Base to be able to comply with the conditions of this tender.
