- Reinforced concrete column bases with the strength of 30 Mpa.
- 4 Manufacturing of 203*203*46kg/m steel columns and beams using O₂ butt welding.
- The use of epoxy grouted dowels to hold the concrete bases to be used.

This tender will be evaluated on the 80/20 points system where 80 points represents price and 20 points represents B-BBEE status level contribution.

The Umsobomvu Procurement and Supply Chain Management Policies, the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and the regulations promulgated under this Act shall apply in the evaluation and awarding of the tender. Interested tenderers who wish to claim preferential points must attach to their tender certified evidence of B-BBEE status level issued by a registered verification agency.

Declaration of Interest forms are available on the web-site (www.umsobomvumun.co.za) which must be filled out and submitted with the tender.

- 1. Tenderers must supply with their tender a valid Tax Clearance certificate and proof of similar work done.
- 2. All tenders should hold good for 90 days from closing date.
- 3. Tenderers must submit a certificate certifying that the tenderer has no undisputed commitments for municipal services towards a municipality or service provider i.r.o. payments which is overdue more than 30 days.
- 4. Statement of goods or services sourced from outside the RSA, and if so what portion and whether any portion of payment from the municipality is expected to be transferred out of the Republic.
- 5. Tenderers must have certified evidence of BBBEE status issued by SANAS, IRBA or SANAS accredited agents.
