PART T1.1: TENDER NOTICE AND INVITATION TO TENDER

The **Umsobomvu Local Municipality** hereby invites tenderers, to tender for the Upgrading of New Ouboks Gravel Arterial Streets to Concrete Block Paved Streets in Colesberg. The works consists of constructing a 4,373-km interlocking block paved road, rip and re-compact the roadbed, construct the sub-base, base and lay 60mm interlocking paving blocks. It is estimated that the contractor must have a **CIDB grading of 6CEPE**, **7CE or higher**. Only tenderers who satisfy the eligibility criteria stated in the Tender Conditions and Tender Data are eligible to submit tenders. Potential emerging enterprise who satisfy criteria stated in the Tender Data may submit tenders.

Tender documents will be available at the offices of Umsobomvu Municipality, No.21a Church street, Colesberg, 9795. A non-refundable deposit of **R 300.00** payable in cash or by bank guaranteed cheque made out in favour of the employer is required on collection of the document

A compulsory briefing meeting by the representatives of the Employer will take place at the municipal offices of **Umsobomvu Municipality** at **21A Church Street, Colesberg, 9795** on **Friday, 02 December 2016** starting at 11:00. Only contractors who attend the compulsory site inspection meeting are eligible to submit their tenders. For contractors who will submit their offer as a joint venture, only one party to the joint venture need to attend the compulsory briefing meeting.

The closing time for receipts of tenders is 12:00, Wednesday, 21 December 2016. Sealed tenders, endorsed with the corresponding tender number and description, UPGRADING OF NEW OUBOKS GRAVEL ARTERIAL STREETS TO CONCRETE BLOCK PAVED STREETS- CONTRACT NO. 01/11/2016 must be placed in the tender box at the office of Umsobomvu Municipality in Colesberg. Postal delivery to reach Umsobomvu Municipality, Private Bag X6, Colesberg, 9795, not later than 12:00 on Wednesday, 21 December 2016, after which the tenders will be opened in public. Telegraphic, telephonic, telex, facsimile, e-mail and late proposals will not be accepted.

The Umsobomvu Procurement and Supply Chain Management Policies, the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and the regulations promulgated under this Act shall apply in the evaluation and awarding of the tender.

Declaration of Interest forms are available on the web-site (www.umsobomvumun.co.za) which must be filled out and submitted with the tender.

- 1. Tenderers must supply with their tender a valid Tax Clearance certificate and proof of similar work done.
- 2. All tenders should hold good for 90 days from closing date.
- 3. Tenderers must submit a certificate certifying that the tenderer has no undisputed commitments for municipal services towards a municipality or service provider i.r.o. payments which is overdue more than 30 days.
- 4. Audited financial statements must be submitted with the tender covering at least three previous financial years (if the tendered amount exceeds R10 million including VAT).
- 5. The tenderer must supply any particulars of contracts awarded by an organ of state for the past 5 years including particulars of any material non-compliance or disputes concerning the execution of such a contract.
- 6. Statement of goods or services sourced from outside the RSA, and if so what portion and whether any portion of payment from the municipality is expected to be transferred out of the Republic.
- 7. All tenderers must provide registration details for Central Supplier Database (CSD).
- 8. Tenderers must have certified evidence of BBBEE status issued by SANAS, IRBA or SANAS accredited agents if claiming preference.
- 9. The bid will be evaluated on the following criteria: Price = 90 points, BBBEE contribution level = 10 points

The Municipality does not bind itself to accept the lowest or any tender. The tender is subject to the General Conditions of Contract\and/or Special Conditions of Contract.
