All municipalities need to plan for maintenance during the operation and when these toilets reach their capacity an understanding of the processes occurring in pit latrines will facilitate better management during their lifespan and identifying suitable options for dealing with the accumulated sludge when toilet eventually reach its capacity. The advert seeks the management, insitu treatment of sludge using additives and disposal options for pit latrine sludge. The supplier should include in the brochure method on how the chemical is mixed, apparatus required as well as mixing ratios. If any training is required for handling the chemical the cost there of should also be quoted. The chemical should be able to turn the mass into bio- degradable for the purpose of percolation or emptying with jetvac truck for disposal.	200
