
- Suppliers must submit their quotes with the following documentation, failure to submit any of the following required documentation will result in your quotation to be disqualified:

 - A Certified CK Certificate and certified ID copies of Director/s of the company.
 - MBD 4,6.1, 7.1, 8 and 9 must be obtained at Umsobomvu Municipality or on the website, and must be completed and signed
