2. All bids will be adjudicated and awarded in terms of the Umsobomvu Supply Chain Management Policy, the Preferential Policy Framework Act 2000 (Act No. 5 of 2000) and the regulations promulgated under this Act, value for money and, capability to execute the contract and the relevant specifications for the drafting of a credible IDP.

3. The Municipality does not bind itself to accept the lowest or any bid and reserves the right to accept the whole or only part of a bid if (a) the bid amounts received are too high; (b) the bids do not comply with the specific bid goals; or (c) objective criteria exist which justify or necessitate the non-acceptance of any bids.

5. Bidders must submit a certificate certifying that the bidder has no undisputed commitments for municipal services towards a municipality or service provider i.r.o. payments which is overdue more than 30 days.

6. Audited financial statements are to be submitted with the bid covering at least three previous financial years.

7. The Bidder must supply any particulars of contracts awarded by an organ of state for the past 5 years including particulars of any material non-compliance or disputes concerning the execution of such a contract.

8. An original current SARS Tax Clearance Certificate in respect of Income and VAT must be attached to the bids.

9. Bidders must submit certified evidence of BBBEE status issued by SANAS, IRBA or SANAS accredited agents.

10. The bid will be adjudicated on the following criteria: Price = 80 points. BBBEE contribution level = 20 points.
